Please review the following information carefully and sign where applicable. Failure to sign the drop ship exemption will result in tax being charged on all orders drop shipped to the states indicated in Section 1 below.

1. Killerspin LLC is required by law to charge sales tax for each state where delivery of drop shipments is made unless you are exempt under the destination state's law.
